

# 2022 TERMS & CONDITIONS MEMBERS BALLOT AND CANDIDATES ALLOCATION FOR A SUITE LICENCE



ENGLAND v NEW ZEALAND TEST MATCH, ENGLAND v INDIA ONE-DAY INTERNATIONAL  
AND ENGLAND v SOUTH AFRICA TEST MATCH

## 1. DEFINITIONS

- 1.1 In these Terms & Conditions, the following words or expressions shall have the following meanings:
- 1.1.1 **Allocation Communication** means a communication sent from MCC confirming the allocation of a Suite to a successful Applicant as further defined in the Suite Terms & Conditions;
- 1.1.2 **Applicant** means any Member applying through the Suite Ballot;
- 1.1.3 **Application** means either an entry in the Suite Ballot by an Applicant;
- 1.1.4 **Candidate** means a candidate for membership of the Club and whose name is in the candidates' book;
- 1.1.5 **First Test Match** means the men's England v New Zealand Test Match scheduled to be played on the Match Day;
- 1.1.6 **MCC** or **Club** means Marylebone Cricket Club, incorporated by Royal Charter under number RC000862 of Lord's Ground, London NW8 8QN;
- 1.1.7 **Lord's** or **Ground** means Lord's Cricket Ground, London NW8 8QN;
- 1.1.8 **Match Day** means any day of the First Test Match, One-Day International or the Second Test Match which is scheduled to be played at Lord's for which an Applicant has been successful in purchasing or been allocated a Ticket(s) which is either (i) the Provisional Match Day; or (ii) if the actual day differs from the Provisional Match Day, the new date notified to the Applicant by the Club;
- 1.1.9 **Member** means a member of MCC from time to time;
- 1.1.10 **One-Day International** means the men's England v India one-day international scheduled to be played on the Match Day;
- 1.1.11 **person** shall be deemed to include any individual, company, corporation or other entity;
- 1.1.12 **Platform** means MCC's ticket platform at <http://tickets.lords.org>;

## 1. DEFINITIONS CONTINUED

- 1.1.13 **Provisional Match Day** means (i) 2 to 6 June 2022 for the First Test Match; (ii) 14 July 2022 for the One-Day International; and (iii) 17 to 21 August 2022 for the Second Test Match, all of which have been provisionally scheduled to be played at Lord's on the Match Day for which an Applicant has been successful in purchasing or been allocated a Ticket(s);
- 1.1.14 **Second Test Match** means the men's England v South Africa Test Match scheduled to be played on the Match Day;
- 1.1.15 **Suite** means either a Experiential Suite, Private Suite or Ultimate Suite (as defined in the relevant Suite Terms & Conditions);
- 1.1.16 **Suite Ballot** means the ballot to allocate and allow Applicants to purchase a Suite;
- 1.1.17 **Suite Terms & Conditions** means the terms & conditions for the daily licence of a Suite for the Match Day copies of which are available on [www.lords.org/termsandconditions](http://www.lords.org/termsandconditions); and
- 1.1.18 **Terms & Conditions** means these terms and conditions.

## 2. SUITE BALLOT

- 2.1 The Suite Ballot is run by MCC.
- 2.2 A Suite is offered for licence via the Suite Ballot. Only Members are eligible to enter the Suite Ballot and no fee or purchase is necessary to enter the Suite Ballot.
- 2.3 Each Suite is subject to availability and for the avoidance of doubt, an Application does not guarantee a Suite.
- 2.4 By entering the Suite Ballot, Applicants will be deemed to have accepted and agreed to be bound by these Terms & Conditions and the Suite Terms & Conditions which are hereby incorporated into these Terms & Conditions save that in the event of any discrepancy between these Terms & Conditions and Suite Terms & Conditions, these Terms & Conditions shall prevail.
- 2.5 The Suite Ballot opens at 10:00 on 3 November 2021 and closes at 16:00 on 26 November 2021. Any Applications received outside this period will not be considered, even if the Application appears to have been registered.
- 2.6 Applicants are limited to one Application for each Match Day. No bulk entries will be accepted and duplicate entries will be disqualified.
- 2.7 Applications may only be made for days one to four of the First Test Match and Second Test Match. For the avoidance of doubt, no entries can be made for the fifth day of the First Test Match and Second Test Match.
- 2.8 Applicants who have been successful in purchasing Suites will receive the Allocation Communication and thereafter the Suite Terms & Conditions shall apply. The outcome of the Suite Ballot selection communicated by MCC is final.

### 3. CANDIDATES

In the event that Suites are available following the Suite Ballot, the Suites shall be allocated on a first come, first served basis to Candidates, subject to availability and thereafter the Suite Terms & Conditions shall apply.

### 4. GENERAL

- 4.1 MCC cannot accept any responsibility for any damage, loss, injury or suffered by an Applicant as a result of making an Application or as a result of not obtaining a Suite.
- 4.2 MCC is not responsible for any technical glitches or malfunctions or any other problems out of its control that result in an Application not being properly received by MCC.
- 4.3 MCC reserves the right to: (i) vary these Terms & Conditions, including without limitation as regards the closing date for the Suite Ballot; (ii) disqualify any Applicant who breaches these Terms & Conditions or has acted fraudulently in any way; and/ or (iii) cancel, amend, withdraw, terminate or temporarily suspend either the Suite Ballot in the event of any unforeseen circumstances or technical reason outside its control, with no liability to any Applicant.
- 4.4 Any Member entering the Suite Ballot who is found to have made false or deliberately misleading statements in relation to any aspect of their Application, then such Member may expect to be referred to the Club's Disciplinary Panel.
- 4.5 Any personal data collected by MCC shall be processed by MCC in accordance with MCC's Privacy Notice, which may be viewed at [lords.org/privacynotice](https://lords.org/privacynotice).
- 4.6 These Terms & Conditions are subject to and governed by English law.
