

## These are the Terms and Conditions for applications for MCC Golf Days in 2021 ("Golf Days").

- 1. The Golf Days and application/booking processes are run by Marylebone Cricket Club ("MCC") using MCC's Ticket Platform, SRO at <a href="https://tickets.lords.org/enGB/categories/Golf">https://tickets.lords.org/enGB/categories/Golf</a>.
- 2. All Full, Senior and Associate MCC Members ("Members") are eligible to apply to participate in the Golf Days.
- 3. Golf Days will be held in accordance with relevant government guidelines. - 4. Places for a Golf Day are subject to availability. Members are limited to one entry for each Golf Day and can apply to play in as many Golf Days as they so wish. Places will be allocated on a first-come-first-served basis. Applications and payments must be made online via MCC's Ticket Platform referred to in Clause 1 above or by telephone on 020 7616 8653.
- 5. Payment for the Golf Days must be by debit/credit card only. Cheque or cash payments are no longer accepted.
- 6. Guests of Members are not permitted to apply to participate in or to play in the Golf Days nor are Members permitted to apply for guests to do so.
- 7. By applying to participate in the Golf Days, Members will be deemed to have accepted and agreed to be bound by these Terms and Conditions.
- 8. The closing date for each Golf Day is four weeks prior to that Golf Day; however, applications will be closed if a Golf Day sells all available places prior to the closing date.
- 9. MCC is not responsible for any technical malfunctions or any other problems out of its control that result in an application not being properly received by MCC.

- 10. A Member's application for a Golf Day shall only be successful upon receipt of
  (a) an email confirmation to the email address registered on their Account or
  (b) the oral provision of a booking confirmation number from the telephone operator.
- 11. MCC cannot accept any responsibility for any damage, loss, injury or disappointment suffered by a Member as a result of not obtaining a place for a Golf Day(s) or participating in a Golf Day(s)
- Only those Members with a current Handicap Index under the new World 12. Handicapping System may win any of the prizes on a particular Golf Day or qualify for the Final at Sunningdale. At the discretion of the Golf Day Manager, an informal prize may be awarded to the competitor with the best score from those Members who do not have a Handicap Index. Players should be aware of their personal CDH ID, which may be requested by the Golf Day Manager to verify their current Handicap Index. Each player's Handicap Index on the day will be converted into a Playing Handicap for the Stableford competition under the rules of the World Handicapping System. Members with a Handicap Index higher than 24 for men or 32 for ladies may play in a Golf Day, but the Handicap Index used for calculating the number of shots they receive will be restricted to those numbers. When both ladies and men are playing on the same Golf Day, an adjustment may need to be made to either the ladies' Playing Handicaps or the men's Playing Handicaps in order to make the Stableford result a fair competition between ladies and men. The adjustment will be undertaken in line with Rule 6.2b(ii) of the WHS Rules of Handicapping which are available from your golf club. The basic principle is that both the Course Rating and the Par must be taken into account when different tees are being used by different competitors. Golf Day Managers will be provided with full guidelines. The number of shots received by Members playing at their own golf club will be reduced by one for those with Handicap Indices of between 1 and 10, and by two for those with Handicap Indices above 10. Unless otherwise stated, the Rules of Golf (as published by The Royal and Ancient Golf Club) will apply.
- 13. Further information regarding tee-times and any other arrangements will be sent by the appointed Golf Day Manager, by email, around two weeks prior to each Golf Day.
- 14. By applying for the Golf Day(s), Members acknowledge and agree that:
  - (a) their name, email address, telephone numbers, golf club membership and handicap will be provided to the MCC Member who has been appointed as the Golf Day Manager. The Golf Day

- Manager will organise tee-times in advance and make all arrangements on the Golf Day itself;
- (b) the price of the Golf Day(s) for non-members of the venue where the Golf Day(s) is/are booked includes green fee, a meal and a supplement of £5 per person to contribute to the cost of prizes and administration;
- (c) the price of the Golf Day(s) for members of the venue where the Golf Day(s) is/are booked includes a meal and a supplement of £5 per person to contribute to the cost of prizes and administration;
- (d) particular requests such as to play with other Members, or for early or late tee-times cannot be guaranteed but will be noted and passed to the Golf Day Manager;
- (e) the dress code for the Golf Day(s) depends on the venue where the Golf Day(s) is/are booked and Members should ensure that they are aware of the dress code before arrival;
- (f) any dietary requirements or restrictions should be made to the Golf Day Manager at least two weeks in advance of the Golf Day so that appropriate arrangements can be made; and
- (g) by attending the Golf Day(s) the Member consents to filming, photography and sound recording of their image, likeness or voice by any means and the use of the same by any means including by commercial distribution without payment.
- 15. In the event that MCC cancels a Golf Day, Members will be entitled to a full refund.
- 16. If, after a Member has made a booking for a Golf Day(s), such Member finds that they can no longer participate, notice of such cancellation must be made in writing to the Club Facilities Department via email: <a href="mailto:clubfacilities@mcc.org.uk">clubfacilities@mcc.org.uk</a>
  A full refund, minus an administration fee of £5 per Golf Day cancelled will be given, provided that MCC has not been charged for the space by the venue or the cancellation is received within seven days prior to the date of the Golf Day. For the avoidance of doubt, if notice of such cancellation is received seven or fewer days prior to the date of such Golf Day, no refund will be given.
- 17. MCC reserves the right to: (i) vary these Terms and Conditions, including but not limited to the closing times for applying for the Golf Days; and/or (ii) disqualify any Member who breaches these Terms and Conditions or who has acted fraudulently in any way; and/or (iii) cancel, amend, withdraw, terminate or temporarily suspend any application in the event of any unforeseen

- circumstances or technical reason outside its control, with no liability to any Members or third parties.
- 18. Any Member booking a Golf Day(s) who is found to have made false or deliberately misleading statements in relation to any aspect of their entry may expect to be referred to the Club's Disciplinary Panel.
- 19. Any personal data collected by MCC shall be processed by MCC in accordance with MCC's Privacy Notice, which may be viewed at <a href="https://www.lords.org">www.lords.org</a>.
- 20. These Terms and Conditions are subject to and governed by the laws of England and Wales.
