

**HOME OF FOOD TICKET PRIZE DRAW****TO WIN A PAIR OF GENERAL ADMISSION TICKETS  
FOR DAY 4 OF THE MEN'S ASHES TEST MATCH SCHEDULED TO BE PLAYED AT LORD'S ON  
1 JULY 2023****TERMS & CONDITIONS**

These are the Terms & Conditions for entry into the draw to win Tickets on the Match Day (as defined below).

**1. DEFINITIONS**

In these Terms & Conditions, the following capitalised words and expressions have the meanings set out against them below:

**Draw:** the draw hosted by MCC to award to an Entrant the Prize;

**Entrant:** any person who has purchased a Home of Food Ticket but excluding employees of MCC, their families, agents or anyone else connected with this Draw;

**Home of Food Ticket:** an admittance ticket for The Home of Food event taking place at Lord's on 9 and 10 September 2023;

**Lord's:** Lord's Ground, London NW8 8QN;

**Match Day:** Day 4 of the Men's Test Match between England v Australia, which is scheduled to be played at Lord's on 1 July 2023;

**MCC:** Marylebone Cricket Club of Lord's Ground, London NW8 8QN;

**Prize:** the Tickets;

**Terms & Conditions:** these terms and conditions; and

**Tickets:** a pair of general admission tickets for the Match Day.

**2. THE DRAW AND ENTRY**

2.1 The Draw is run by MCC.

2.2 The Prize is awarded via the Draw. Entries into the Draw will be made automatically following the purchase of a Home of Food Ticket and only Entrants will be entered into the Draw and are limited to one entry into the Draw.

2.3 By purchasing a Home of Food Ticket, Entrants will be deemed to have accepted and agreed to be bound by these Terms & Conditions and any terms and conditions for the applicable Prize, which are hereby incorporated into these Terms & Conditions save that in the event of any inconsistency between these Terms & Conditions and any terms and conditions for the applicable Prize, these Terms & Conditions shall prevail.

2.4 The Draw opened on 19 April 2023 and closes at 23:59 on 21 June 2023. Any entries received outside this period will not be considered, even if the entry appears to have been registered.

2.5 The winning Entrant will be drawn randomly from the entries in the Draw following the closure of the Draw and will be notified as soon as reasonably practicable via email to the email address submitted by the Entrant as part of purchasing the Home of Food Ticket(s) (**Confirmation Email**). The outcome of the Draw selection communicated by MCC is final and no further correspondence will be entered into.

2.6 The winning Entrant must reply to the Confirmation Email within 5 days of the date of the Confirmation Email, due to the proximity of the closing date of the Draw and the Match Day in

order to redeem the Prize. In the event the winning Entrant does not comply with this Clause 2.6, MCC reserves the right to run the Draw again and reallocate the Prize to another Entrant.

- 2.7 The winning Entrant will receive the Prize within 48 hours of the Match Day and the Prize will be issued to the email address used by the Entrant when they purchased the Home of Food Ticket(s). For the avoidance of doubt, the Prize shall be subject to the 2023 Terms & Conditions for the Sale and Allocation of General Admission Tickets and Wheelchair Tickets (International Matches) a copy of which is available [here](#).
- 2.8 MCC is not responsible for any technical glitches or malfunctions or any other problems out of its control that result in an entry into the Draw not being properly received by MCC.
- 2.9 MCC cannot accept any responsibility for any damage, loss, injury or disappointment suffered by an Entrant as a result of entering the Draw or as a result of not winning the Prize.
- 2.10 Cash or credit alternatives to the Prize will not be offered in any circumstances and the Prize is not transferable.
- 2.11 The Prize must not be sold or auctioned for profit under any circumstances.

### 3. **GENERAL**

- 3.1 MCC reserves the right to (i) vary these Terms & Conditions at any time, including without limitation to comply with any Government guidance or restrictions and/or vary the closing times for entering the Draw and/or (ii) cancel the use of the Prize of any Entrant who breaches these Terms and Conditions or who has acted fraudulently in any way; and/or (iii) cancel, amend, withdraw, terminate or temporarily suspend the Draw in the event of any unforeseen circumstances or technical reason outside its control, with no liability to any Entrant.
- 3.2 MCC will not be liable for any loss, expense or damage which is suffered or sustained in connection with the Draw or accepting or using the Prize, except for any liability which cannot be excluded by law.
- 3.3 Any personal data collected by MCC shall be processed by MCC in accordance with MCC's Privacy Notice, which may be viewed at [lords.org/privacynotice](https://lords.org/privacynotice).
- 3.4 If any provision of these Terms & Conditions is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that these Terms & Conditions shall otherwise remain in full force and effect and enforceable.
- 3.5 No third party shall have any right to enforce any of these Terms & Conditions under the Contracts (Rights of Third Parties) Act 1999.
- 3.6 These Terms & Conditions and the draw shall be governed by and construed in accordance with the laws of England and Wales and the English courts shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Terms & Conditions.
